Application: General purpose indicating element when connected to an NTEP certified and compatible weighing/load-receiving element.

Identification: The self destructive identification badge may be found on the back of the indicating element.

Sealing: A lead wire security seal must be used by sealing two (2) predrilled sealing screws on the back of the indicator.

Test Conditions: The Model(s) BW, BWS, and CWS digital weight indicators were submitted for this evaluation. The emphasis of the evaluation was on device design, operation, and compliance with influence factor requirements. The indicator was interfaced with a load cell simulator and then tested for accuracy over a temperature range of -10 °C to 40 °C (14 °F to 104 °F). The indicators were interfaced with a load receiving element, Tscale PB4252, and a printer. The device was tested for discrimination, power interruption, zero tests, and print format. Additionally, the device was tested with a supply voltage of 100VAC to 130VAC and 5.8VDC to 7.2VDC.
